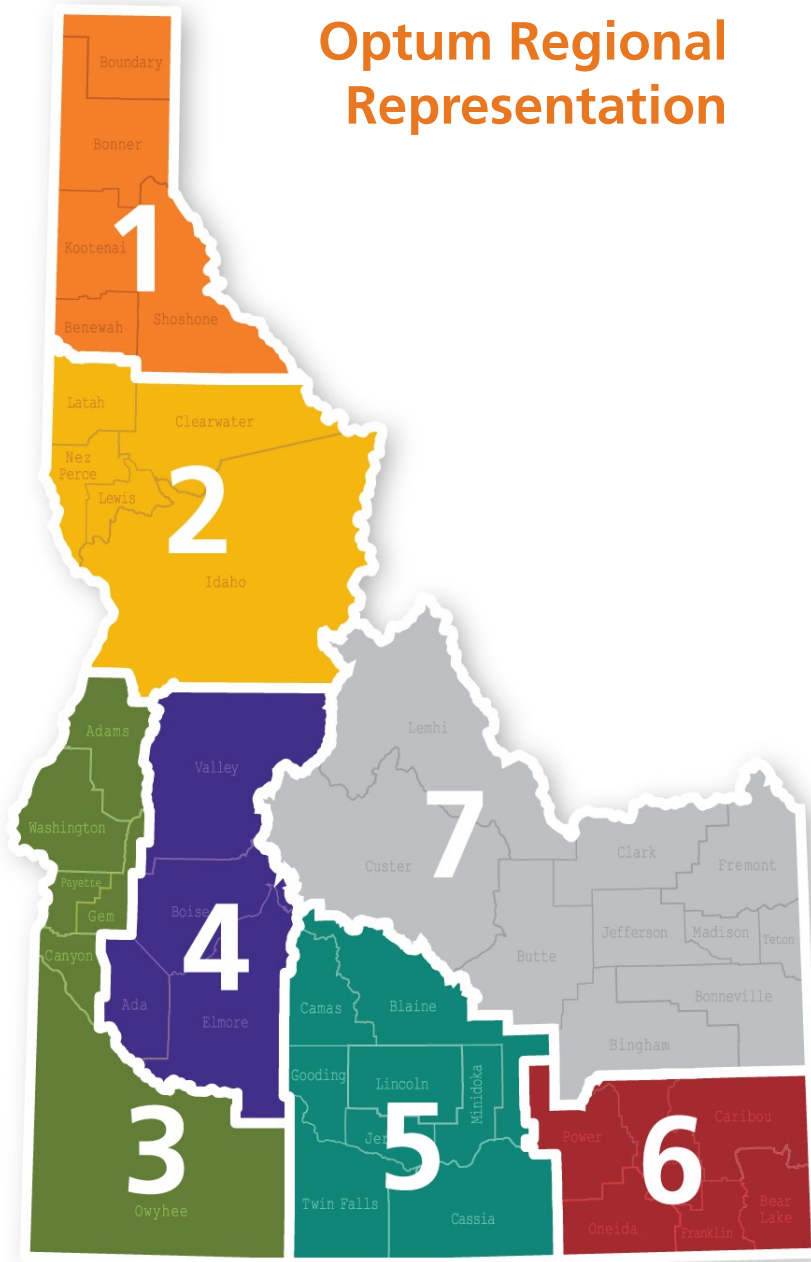


Optum Regional Representation
